Prof Leon Verstappen

The progress of a Dutch initiative for developing a fair compensation protocol in a participatory process will be presented. The Dutch Land Governance Multi-Stakeholder Dialogue has initiated the development of a protocol on fair compensation in case of land tenure changes, expropriation in particular. This protocol will serve as guidance to the various actors operating in this field, such as affected people, governments, project developers, financers, donors and civil society organisation in cases where fair compensation needs to be determined. This session will present the progress of the first phase, a review of existing international guidelines and the findings of a stakeholder consultation on the key challenges from the field that call for additional guidance on compensation.
